(iv) Mattool Village: 359/1A and 359 1 B


And enclosed by the boundaries as specified below

EAST: Both banks of the river including the Mattool creek for one mile (1.61kms) from Mattool point within 50 yards (45.72m) of high water mark spring tides from the mouth up to and including the Baliapatam ferry. All other creeks excluded.

WEST: A line connecting the western end of the northern and southern boundaries in 10 fathoms of water.

SOUTH: A line drawn due west from south boundary pillar one mile south of the left bank of the mouth of the river to 10 fathoms of water.

NORTH: A line drawn due west from north boundary pillar one mile (1.61Km) north Mattool point to 10 fathoms of water

In exercise of powers conferred under sub section (a) of section 8 of the Customs Act, 1962, I, P.R.Chandrasekharan, Commissioner of Central Excise and Customs, Calicut Commissionerate, Calicut hereby specify the area at Survey No. 144 of Azhikode Village as detailed in the table below to be a place for unloading of imported goods and loading of export goods or any class of such goods.

Further, in exercise of the powers conferred under sub section (b) of section 8 of the Customs Act 1962, I also specify the survey numbers of the villages mentioned below as the limits of the Customs area in respect of Azhikkal Port

- (i) Azhikode Village: Survey Nos. 17, 18, 19, 28, 29, 88, 89, 90, 95, 112, 113, 114, 115, 116, 119, 124, 125, 138, 139, 141, 142, 143, 144, 149, 151, 156, 157, 158, 159 and 160. Out of this Survey No. 143 & 144 are the land owned by Azhikkal Port and the rest belong to private parties.

- (ii) Valapattanam Village: Survey Nos. 1, 2, 3, 4, 5, 25, 28, 48, 49, 61 and 62. Out of this Survey No. 1 which is water portion of Azhikkal River owned by Port Department.
